

COLONY SWIM CLUB NEWS

Welcome to the summer 2012 season at Colony Swim Club. The Board of Directors is pleased to announce that the 2012 annual dues and maintenance fee have stayed the same as last year. The 2012 Capital Improvement assessment will be \$100. Please remember the following based on questions frequently asked by our fellow members:

1. **The signature card, which must be completely filled out, must be sent in with your dues check. Dues and a completely filled out signature card must be postmarked by March 15th to avoid the late fee. Dues without a completely filled out signature card will be deemed as not received. If dues are not received by April 15th, membership is assumed to have been terminated. If postmark is after March 15th, you MUST include the late fee in your check – no exceptions.**
2. Only eligible family members listed on the signature card may use the membership. Guests must pay the guest fee and may not substitute for a family member.
3. Members must be present at the pool when hosting guests.
4. Grandparents of Colony members (who are not members of Colony) may attend the club free of charge only when their grandchildren are present at the club. They are not considered members of the club.
5. Grandchildren of Colony members (who are not members) over the age of 2 must pay the guest fee and attend the club only when their grandparents are present at the club. Grandchildren may take swim lessons during session 4 and pay the regular fee for each class. Grandchildren who are not members of Colony may not participate on the swim team.
6. Any unmarried children over the age of 25 are not eligible to be part of a family membership even if they live at home. They may attend as a guest with a member or take out a single membership.
